that we share with you Lancaster City Alliance's 2024–2025 Impact Report. We have much to celebrate and are excited for what lies ahead. Most of all, we are incredibly grateful to the volunteers, partners, and committed stakeholders who play such important roles in the vitality and development of Lancaster City. Thanks to your support and partnership, the last year saw continued growth of our signature programs and the exciting launch of several new initiatives.

- We secured additional funding to expand our façade improvement program to even more neighborhoods throughout the City, enhancing homes and businesses. This includes an exciting new initiative, "Light Up Lancaster," to light the façades of prominent Downtown buildings.
- Our Welcoming Public Spaces initiative, in partnership with the Downtown Investment District, City, Police, Homelessness Coalition and others, continues to work to assist those in need, while ensuring that our public spaces are enjoyed by all.
- Our Merchant Committee meetings continue to grow, bringing together small business owners monthly to support continued growth.
- Through our management of the City Revitalization & Improvement Zone (CRIZ) program, we continue to assist projects and businesses, small and large, and are excited to embark on the planning effort for the Stadium Area.
- We are actively engaged as a community stakeholder in shaping a vision for the future of the East End, including the Lancaster County Prison site, as plans advance to decommission the facility and construct a new one outside of the City.
- With the City and SoWe partners, we are collaborating to build momentum in the Manor Street area through facilitating a CRIZ expansion and early partnership discussions to position the former Kunzler & Co. plant as a future anchor for community growth.

- Increasing our urban forest through the planting of 29 bare-root trees in City neighborhoods, using natural green beauty to enhance our urban spaces.
- Through one of our largest bodies of work, we continue to implement the Building On Strength Economic Development Strategic Plan. With the help of our Executive Leadership Teams, we will soon release a refreshed plan with realigned priorities as we head into the final five years of the 15-year initiative.
- Internally, we underwent an exciting new reorganization and strategic plan refresh, including adding new team members to better serve our thriving City. We also celebrated our two new Vice Presidents, Colleen Wagner and Jeremy Young, for their years of leadership and dedication to the work of LCA and to Lancaster City.

In the pages of our report, we invite you to review all that was accomplished in more detail. And remember...we cannot do what we do without the shared time and expertise of our Board, investors, volunteers, and partners. You are at the heart of everything we achieve.

Our work is not done, and we are grateful to continue serving Lancaster with all of you.

NEW THIS YEAR

We are grateful to the dedicated volunteers who serve on our six Executive Leadership Teams (ELTs) to identify and address issues affecting the City. Thank you to the volunteers who helped to accomplish the following work:

I appreciate working with a Board and a team that is truly invested in seeing everyone share in the success of Lancaster City. We address many complex and critical issues, like homelessness, with open minds and a balanced perspective. We recognize that effective community response can't only be through the lens of businesses or the local economy but also recognizes our unhoused neighbors as part of our community. Because of this we approach the conversation with an emphasis on outreach, connection to resources, and collaborative solutions that benefit our unhoused neighbors and business owners alike."



The **Advocacy ELT** worked with members of the Home Rule Charter, the Mayor, the Chamber Advocacy Committee, and key business leaders on the Home Rule campaign. In the spring of 2025, this group partnered with the Lancaster Chamber and LNP to host a Mayoral Forum.

The **Chairpersons Council** welcomed David Hanson as the new Chair, and the Council continued to bring key economic development organizations together to advance strategic opportunities that further the success of the City of Lancaster, including the workforce collaborative study, the Land in Lancaster site launch, and addressing homelessness in Lancaster City.

The **Community Safety ELT** worked with the Lancaster City administration, Lancaster City Alliance & the Downtown Investment District, the Lancaster County Housing & Redevelopment Authority, Lancaster City Police, Tenfold, and the Lancaster Safety Coalition to create a group called Welcoming Spaces, focused on the continued discussion around creating a clean and safe community for all.

The **Economic Development and Planning ELT** has supported the recalibration of the Building On Strength Economic Development Plan to identify and strategize priorities and challenges for the City up to 2030. This work has been in coordination with Lancaster City in anticipation of the newly developed Tourism Master Plan.

The **Finance and Development ELT** provided expert oversight of the operational budget and cash flow resulting in higher revenue generation than budgeted. Additionally, this team oversaw LCA's investment portfolio and refined a position statement on operational reserves.


The Marketing ELT identified key marketing opportunities outlined in the recalibration of the Building On Strength strategic priorities. The focus has been on aligning current tactics with refreshed goals and clarifying the role Lancaster City Alliance plays with attracting residents to new developments and businesses to storefronts.

BUILDING ON STRENGTH

Building On Strength, Lancaster's community-owned economic development strategic plan, has guided revitalization efforts since its development by LCA in 2014 and adoption by City Council in 2015.

Over the past year, LCA worked with our partners to complete a strategic update, aligning Building on Strength with Our Future Lancaster, the City's new comprehensive plan. This recalibration will guide the final five years of the plan's implementation through 2030.



FAÇADE IMPROVEMENT GRANT PROGRAM HIGHLIGHTS

SINCE 2019, Lancaster City Alliance has supported 126 façade improvement projects. These projects represent over \$1 million in grants awarded or pending, leveraging nearly \$2 million in reinvestment in commercial hubs like King Street and South of King.

During the past fiscal year, 23 projects were completed or in progress, with emphasis on restoring and enhancing building exteriors in keeping with Lancaster's historic architecture and unique character. Thanks to \$225,000 in newly secured funding through PA Department of Community & Economic Development's Main Street Matters Program, High Foundation, and Tenfold / SoWe, the program is expanding into previously unserved parts of the city, improving geographic equity and broadening its impact, with an anticipated result of up to \$450,000 in reinvestment in city neighborhoods and commercial corridors.

SMALL BUSINESS GROWTH IN LANCASTER CITY

THE CITY CONTINUES to see a trend of positive economic growth in alignment with Building On Strength thanks to at least 45 new business openings or expansions in FY2024-25, including many new food & beverage and retail businesses. Lancaster City Alliance, in partnership with the Lancaster Chamber, celebrated openings with Ribbon Cutting ceremonies for more than 40 new businesses over this last fiscal year.

WELCOMING SPACES IN THE DID

THE DOWNTOWN INVESTMENT DISTRICT, in partnership with the Lancaster City Alliance, continues to host Welcoming Public Spaces Stakeholder meetings. An action plan, focusing on safety, cleanliness, outreach, and positive space activation has been developed to guide the committee in their work and collaboration with neighborhood stakeholders.

During the past year, Lancaster City Alliance and the DID have continued to make great strides. The Light-Up Lancaster plan is now complete and implementation has begun. A new lighting design, emphasizing safety and the historic beauty of the City, will be completing first phase and illuminating key buildings by the end of 2025.

STREET OUTREACH SPECIALIST

DOWNTOWN INVESTMENT DISTRICT outreach specialist, Regina Cooper, made over 750 connections with individuals experiencing homelessness during this past year. Since beginning her work in Lancaster City in 2023, she has supported 135 people with accepting rehabilitation, helped 104 individuals with getting into shelters or permanent housing, and facilitated the reunion of 17 others with family outside of Lancaster County.

STADIUM DISTRICT SMALL AREA PLAN

a \$300,000 contract in February 2025 between the CRIZ Authority, and a consultant team comprised of MKSK, TAIT, and RGS Associates to plan for the future development in a roughly 50-acre area around Penn Medicine Park, in alignment with the Building on Strength Economic Development Strategic Plan.

We leverage corporate and private contributions with supplemental funding from grants and successfully manage each dollar we receive.


IN THE PAST YEAR, our \$1.5 million operating budget was supported by the \$850,000 invested by our Corporate Partners in our Mission and Work.
Additionally, \$750,000 in grant money was received to launch and partially fund special projects, including the Light Up Lancaster initiative and Façade Improvements.
